Texas Ban on Gay Marriage Struck Down

"Texas, on Wednesday, became the latest state to have a federal judge strike down its same-sex marriage ban, thanks to a sweeping decision holding that its current prohibition has no 'legitimate governmental purpose.' The ruling, by San Antonio-based Judge Orlando Garcia, will not take effect immediately: Its enforcement has been stayed while the case works its way through the appeal process, meaning same-sex couples in Texas cannot get married for the time being...."

Texas Democratic Party chairman Gilberto Hinojosa called Wednesday "a historic day for the LGBT community and the state of Texas," while the National Gay and Lesbian Task Force's head predicted the ruling "hastens the day when all loving couples who simply want the ability to share the benefits and responsibilities of marriage can."...

The Future of Brain Implants

What would you give for a retinal chip that let you see in the dark or for a nextgeneration cochlear implant that let you hear any conversation in a noisy restaurant, no matter how loud? Or for a memory chip, wired directly into your brain's hippocampus, that gave you perfect recall of everything you read? Or for an implanted interface with the Internet that automatically translated a clearly articulated silent thought ("the French sun king") into an online search that digested the relevant Wikipedia page and projected a summary directly into your brain?

Science fiction? Perhaps not for very much longer. Brain implants today are where laser eye surgery was several decades ago. They are not risk-free and make sense only for a narrowly defined set of patients—but they are a sign of things to come....
