Please see the attached, in which TDCJ claims exemption of information of great public interest and accountability. There is nothing specific that would threaten the security of TDCJ or any person, prisoner or employee. In fact, as seen, they *have* released some already to the press.

See also the attached letter I sent to 105 stakeholders in September, exposing in that 16 Killings Letters some incompetence, which is the real reason for hiding the info asked.

They released to the public, as you can see, the NUMBERS of killings and very specific kinds of contraband found—what is the rest of the story? I am also a writer for the *Tyler County Booster* newspaper. These numbers and those numbers relative to specific prison units are public information—*period*—and the reports they made, IF ANY.

If you choose to redact, TDCJ can give the number of system-wide reports, if any.

As you can see in the 16 Killings Letter, that is a question I asked *then*, whether TDCJ just found contraband tossed in the dayrooms when the lockdown started, or FOUND in a cell and wrote a disciplinary. That is a critical question to operations, my guess—which I hope I am wrong—leads to less actual contraband "found upon a search" and more. My guess is that TDCJ did NOT write many disciplinaries, or very few, but *implied* to the press in a manner that made their searches more diligent than they likely were, *sound* like they *found* a lot that was essentially trashed by the prisoners themselves—i.e., that TDCJ did more *work* than they actually did.

Obviously, a key element is which prisons had vastly MORE than others—a public interest.

Also very important are the *reports*, or the *lack* of them. You know the public has a vested tax-paying interest in precisely what the public is paying for during these lockdown. TDCJ is not the personal fiefdom of the directors or wardens but owned by Texas citizens, like me!

Because I am not on the inside anymore—given the documented nefariousness in my massive *When Texas Prison Scams Religion*—there is likely a more specific way of asking for the statistics they want so badly to keep secret under the color of law, stats they *never* publish, or submit to *real* analysis. Yet my request is clear enough for the *numbers* in total and *numbers* per specific prison, as well as any "reports" they did or the exposure of **no** *real* **report**.
