Stay of Soledad cross removal extended

U.S. Supreme Court Justice Anthony Kennedy ordered Friday that his temporary stay protecting the Mount Soledad cross extend until state and federal courts can hear the city of San Diego's appeal this fall. In blocking a federal judge's order that the city remove the cross by Aug. 1 or face a daily fine of \$5,000, Kennedy also indicated that the full court may want to review the controversial case.

Kennedy said the court, which refused three years ago to get involved in the dispute, may consider it because of two new factors favorable to cross proponents. He cited legislation to make the area a national veterans memorial and a successful ballot initiative in which San Diegans overwhelmingly voted to transfer the land to the federal government.

Texas' patient care law at hub of Houston dispute

Life-support case 'raises questions of whether the law might be used to bury mistakes'

Texas' controversial **futile care law** is at the center of a drama at Memorial Hermann Hospital involving a patient who suffered brain damage after her breathing tube became disconnected.

Doctors invoked the law, which allows hospitals to remove life support in cases deemed medically futile, two weeks later, after deciding 29-year-old Kalilah Roberson-Reese was in a vegetative state.

"This case raises questions of whether the law might be used to bury mistakes," said Jerri Ward, an Austin attorney who this week asked a judge to stop Memorial Hermann from withdrawing life support from Roberson-Reese. "At the very least, there is an appearance of a conflict of interest that should preclude a futility review committee from making a life-or-death decision before an independent investigation is made." Dr. William Winslade, an ethicist at the University of Texas Medical Branch at Galveston, said the case "raises questions about how quickly these decisions should be made in the face of potential litigation." Lawyers are studying Roberson-Reese's medical charts at her mother's request to determine whether to file a malpractice lawsuit.

According to hospital medical charts, nurses discovered Roberson-Reese was unresponsive after finding her tracheal breathing tube had become disconnected June 12. That was more than a month after doctors performed an emergency cesarean section, trying to save the life of her 33-week fetus. The baby died....

Neurologists say such "wakefulness without awareness" is the hallmark of a vegetative state, which becomes a persistent vegetative state after one to three months.

It was such movement and apparent responsiveness that family members cited in the case of Terri Schiavo, a Florida woman in a persistent vegetative state for 15 years. Widely circulated video of Schiavo during the years-long legal battle between her husband and her family appeared to show Schiavo was aware of people and her surroundings. After her death in March of 2005, doctors who performed her autopsy found her brain had shriveled to half its normal size and suffered damage in nearly all its regions, including the one responsible for vision....


Doctors subsequently determined Roberson-Reese's case was futile and, on June 26, the hospital's futility review committee voted to approve the recommendation. That set a timetable under which the hospital could legally remove the patient from life support July 8. Deason was not at the meeting.

Efforts to transfer Roberson-Reese are focused on Mayfield Care Center, a nursing home in San Antonio. Texas Right to Life, which is assisting Deason in the matter, said the facility is open to such a transfer but has no vacancies at the moment. Many other facilities in the state already have refused to accept Roberson-Reese as a patient.

***The Da Vinci Code* by Dan Brown – My Two Cents – Part Two**

10. **The Pope Must Die(t) 1991**- an unqualified goofball priest (Robbie Coltrane) is named pope and battles against the mafia-controlled Vatican
9. **The Crime of Father Amaro 2002** – Gael Garcia Bernal plays a young and sexy priest who begins a torrid affair with a 16-year-old girl. Major success in Mexico, and Catholic groups in Mexico called for a ban. Portuguese critics claimed the adaptation wasn't faithful to the novel.
8. **Monty Python's Life of Brian 1979** – Born next door to Jesus, Brian of Nazareth (with waist long hair and beard) can't shake the fanatics who think he's the Messiah. A leading rabbi said “Brian” was “produced in hell.” Banned in Ireland, Norway, Italy, parts of UK, but became a huge box office hit.
7. **Water 2006** – a 7-year-old widow befriends a gorgeous prostitute in a home for Indian widows, who are forced to live in poverty. A Hindu mob burned down Deepa Mehta's original set and threatened her. A Gandhi-era drama.
6. **Priest 1994** – The head priest of a Liverpool church likes to shag the pretty housekeeper, while the younger priest acts on his homosexual desires. The Catholic League urged mass boycotts of Disney when Miramax planned a Good Friday opening. Financial flop.
5. **Dogma 1999** – Christ's last descendent (an abortion clinic worker) must prevent two rogue angels from ending humanity. Catholic League publicly dissed Miramax and Disney. Director Kevin Smith claimed he received 300,000 pieces of hate mail.
4. **The Passion of Christ 2004** – Mel Gibson's Aramaic epic was a brutal depiction of Christ's last hours on earth. Evangelical sold out multiplexes, Jews protested the film as anti-Semitic. Made over \$370 million, 10th-highest-grossing film of all time.
3. **The Da Vinci Code 2006** – Murder at the Louvre uncovers an age-old battle between the Catholic sect Opus Dei and a secret society, the Priory of Sion. Several Catholic and Opus Dei groups called for boycotts, and one cardinal suggested legal action. Early reviews not positive, but Tom Hanks not a flop in years.
2. **The Message 1976** – Islam's origins with Anthony Quinn as Hamza. Mistakenly believing Mohammed would be depicted in the film (forbidden by Shari'a), some Black Muslims took hostages and demanded the movie never be shown. Lukewarm reviews and cold public reception.

1. **The Last Temptation of Christ 1988** – Martin Scorsese’s take on the eponymous novel, about what Jesus might have imagined as he hung on the cross. Conservative Christians protested peacefully; in France a Molotov cocktail injured moviegoers. Bust financially.
