

e. On UTMB's Psych Work in TDCJ—Follow Up on Zero Reports

Maness 12-28-24 - I sent the following to follow up. UTMB balked, and after the back and forth, they appealed to the Texas AG, even for the "names" of the reports.

2-8-25 – **Got the Names from TDCJ** – as seen below. For all of the emails and reports, as they come in during the months ahead, likely not until July to September 2025.



CLARIFICATION on *When Texas Prison Scams Religion* after finally getting a little information. Yet, in 2021, TDCJ had nothing, zero, referring to UTMB for reports and the UTMB scrambled and had nothing, not even the names of the reports TDCJ gave above. The following was published in *When Texas Prison Scams Religion* (2023) based on the OR requests in 2021.

On 12-28-24, I did a follow-up OR, and UTMB balked again, seeking Texas AG's approval and **even refused the names of the reports;** yet TDCJ properly gave the report names, see here for full package that will even be updated after this letter is sent.

Dear OR Coordinator for UTMB,

I am making an official Open Records request in a follow up of a request made in May of 2021 to Owen J. Murray, then Vice President UTMB Correctional Managed Care, asking for specifics on the psych work UTMB performs in TDCJ at a cost to TDCJ for \$314 million in 2021: see the extensive email exchange, as if no one has as ever asked for ANY psych reports, http://www.PreciousHeart.net/Seminary/UTMB-Zero-TDCJ-Stats-2021.pdf and which in 2024 TDCJ spend \$321 million, page 1, http://www.TDCJ.texas.gov/divisions/cmhc/docs/cmhcc_financial_reports/FY24_4th_Qtr_Report.pdf, an enormous sum for ZERO reports to TDCJ. Has UTMB continued the practice of ZERO reports to TDCJ on its psych care?

My OR request is five-fold:

- 1. How many prisoners in TDCJ are DSM-5 diagnosed with ASPD, Antisocial Personality Disorder?
- 2. List of the psych services provided TDCJ in FY 2024, kinds of counseling groups, counseling sessions, etc. given to prisoners.
- 3. Copies of any monthly, quarterly, annual reports created by UTMB for review, or whatever is compiled by UTMB for psych services to TDCJ for FY 2024.

- 4. Copy of all UTMB psych reports given to TDCJ in the last four FYs 2022, 2023, 2024 as any kind of an accounting for the millions of dollars TDCJ spent for those years.
- 5. Copy of basic staff titles and salaries of psych staff providing services to TDCJ for FY 2024.

Believe it—there is **no TDCJ operational use for any of the UTMB reports,** especially the identification of the Antisocial Personality Disorders for any in-prison staff help. Of course, the **DSM-5 does not yet diagnosis the "psychopath,"** though when it does it will include the classic work of Robert Hare's "Gold Standard" assessments, as explained in chapter 2 of *When Texas Prison Scams Religion* (2023) and still ignored by TDCJ.

After the names of the reports given by TDCJ (that UTMB refused to give), I requested copies of the reports.

I guess I could have organized the responses better. I just combined all the PDFs of the reports from TDCJ along with the UTMB letter to the AG appealing, as UTMB did not want to give the reports. Notice on the reports given, that there is nothing useful to TDCJ admin on dealing with severe psych patients. STILL nothing on prisoners with antisocial disorders, and, as predicted, nothing on psychopathy.

As the info allowed by the TX AG from UTMB, those will be added when they come. Do not expect anything significant.

On January 15, 2025, The University of Texas Medical Branch at Galveston ("University") received a request for information from Michael Maness ("Requestor"). The University subsequently sent the request to The University of Texas System ("UT System") for handling with your office.

In accordance with section 552.301 of the Texas Government Code, we now send this request for decision within ten business days from the date the request was received, excluding the January 20, 2025, Martin Luther King, Jr. Day, when the University was closed. UT System has copied the Requestor on this letter brief in accordance with section 552.301(d).

The Requestor seeks access to the following information:

Perhaps this is another OR request, yet I am officially asking what reports you do have that you create regarding your psych services to TDCJ?

Are there ANY reports you send to TDCJ? That does not need an AG answer,

If so, what are the names of the reports? That does not need an AG answer either.

Of course, if the list is long, then as you know, the only ones I am interested in are those regarding UTMB psych care in TDCJ. Maybe I should have asked first for the "ANY" first and "names"--whatever, and I apologize for any confusion. While we can wait for weeks for the reply from the AG's office on your forward, and in light of that letter, may I ask for a simple answer implied in your letter regarding not having to create a report. I have waited over a

month from time to time. Sometimes, that AG request was just to delay an answer. Yet this request is simpler, are there ANY reports you regularly send to TDCJ on psych care? Yes X#, or none?

Please note the information responsive to the request is also responsive to the prior request for information submitted to your office as OGC# 218970. Please consider this request jointly with the prior request. The responsive information was submitted with OGC# 218970. Although the Requestor seeks the names of reports the University sends to TDCJ, the University does not maintain a list of responsive reports. Rather, the names of the reports are found within the reports responsive to the prior request.

As with the prior request, the University takes no position on the release of the remaining requested information but notifies you of possible third-party concerns. The University has notified the affected third party of the request and sent notice to advise it of its opportunity to object to the release of its documents. The third party has not agreed to the release of the information at issue.

Responsive information may be excepted from disclosure under certain provisions in the Texas Government Code. Specifically, sections 552.101, 552.104, 552.110, 552.113, and 552.131 may apply if the requested information reveals company trade secrets, financial and commercial/competitive information including, but not limited to, the pricing structure and details of the services provided by the third party. Therefore, the University will withhold this information pending a decision from your office.

In summary, the University requests your opinion to afford the affected third party the opportunity to object to the release of its information in accordance with section 552.305 of the Texas Government Code.
